B.1 The successful bidders has to transport of construction material (MS PLATE AND SUTRUCTURAL STEEL)-30 MT within **01 day notification** at Loading point on any working day (Except Sunday/other Holidays)

#### B.2 Loading & Unloading:

- a. Loading will be done by SAIL, Dankuni.
- b. Unloading will be done by B and R at unloading point.
