

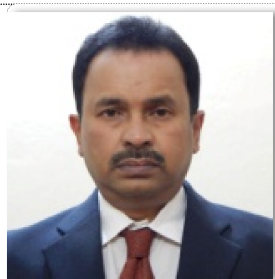
BOARD OF DIRECTORS
